The Board meeting commenced at 1.30 p.m. and concluded at 2.00 p.m.

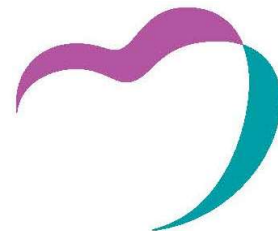

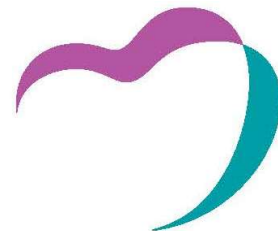
